Traficop Keeps Traffic

Flowing Safely in Community

"You can't offer customers a uniformed officer to keep traffic flowing safely in their neighborhood, but you can install a traffic calming device that performs the same function." According to one Professional Pavement Products, Inc. (PPP) customer, "Traficop Speed Cushions does just that."

BACKGROUND

Ivy Lakes Estates is a gated community of 551 mid- to upscale single family homes located in Pasco County, Florida. This family-oriented community is accessed by a single entrance where residents can use a remote control to open the gates and visitors gain access through use of a key pad.

The community is about eight years old with residential and commercial growth popping up all around. The speed limit on the roadway paralleling the development is 35 mph, but traffic typically travels at speeds in excess of 50 mph.

This tendency to speed was pouring over onto Ivy Lakes' entrance road resulting in compromised safety and security of the neighborhood; as well as costly, repetitive damage to the gates and related electronic control equipment.

THE CHALLENGE

The homeowners' association and property management company initially tried to alleviate the problem through education, but the communications to homeowners had no impact.

"We needed traffic to slow down at the gate so we could get a clear photo of each tag number with our security cameras," said Leigh Slement, Ivy Lakes' primary representative with property management company Property Group of Central Florida.

"It was primarily a safety issue," Slement said, "but property damage control was also critical. Vehicles were damaging the gate and related equipment."

The decision was made to tap resident handyman Wayne Gaskill of Gaskill Handyman Services to work with the county and recommend how best to protect the community. Gaskill had lived in the community for several years and served on the neighborhood safety committee. He was the obvious go-to person when problems arose with the access road and gate entrance.

THE SOLUTION

Gaskill consulted with Florida Design Consultants and Pasco County to develop the specifications for the project. It was determined the most effective solution would be to install traffic calming devices along the entrance route.

Asphalt speed bumps were quickly ruled out as being too expensive to install and remove, not to mention more disruptive to traffic during the installation. Since the community was planning to repave the roadway in the near future, Gaskill wanted a product he could easily remove and reinstall.

"Traficop is larger than a traditional speed bump which slows traffic to about 15 miles per hour," said Smith, "whereas the wider Traficop slows traffic to a safe and reasonable 20-25 miles per hour with less of a jolt." Traficop is a rubber speed cushion that is made from premium recycled truck tire shard mixed with a two-part polyurethane binder and then heated and pressurized at 160 tons.

Other traffic calming devices can increase emergency response times by up to nine times.

The Traficop's exclusive anchor system allows for fast and secure installation with the ability to be removed and relocated. This unique feature, especially when combined with the modular design that enabled individual sections of the speed

All said and done, the Traficop has higher visibility and longer durability than traditional asphalt speed bumps. While not necessarily a factor in Ivy Lakes' situation, a highly sought benefit of reducing vehicle speeds is reducing cut-through traffic. In effect, Traficop safely returns the neighborhood streets back to the neighbors.

THE RESULTS

"Traficop is doing exactly what we wanted by slowing traffic from 35 mph to a crawl through the gate," said Slement. "It's a great solution. There's lots of reflective striping so

you're not going to fly over them."

Gaskill often hears from his neighbors on the new addition to the neighborhood.
